PCC President Mahesh Kumar Goud Slams BJP Over BC Reservations at Jantar Mantar Protest

New Delhi, August 6: Telangana Pradesh Congress Committee (TPCC) President and MLC Mahesh Kumar Goud launched a scathing attack on Union Minister Kishan Reddy and BJP leaders during the massive BC Maha Dharna held at Jantar Mantar, New Delhi. The protest, led by Chief Minister A. Revanth Reddy along with his Cabinet colleagues, aimed to press the Centre for implementing 42% reservations for Backward Classes (BCs) in Telangana. Addressing the gathering, Mahesh Kumar Goud questioned whether Kishan Reddy could even file a nomination in Secunderabad without the support of SCs, STs, and BCs. He criticised BJP National General Secretary Bandi Sanjay for winning elections



in the name of BCs but now "shamelessly backing" Kishan Reddy in opposing enhanced reservations. Goud alleged that winning elections by exploiting religion had become a habit for BJP leaders, branding them as "good-for-nothing weaklings." He challenged Kishan Reddy to watch a video of Prime Minister Narendra Modi stating that reserva-

tions were being given to Muslims in Gujarat, and to study similar provisions in Uttar Pradesh. He accused BJP MLAs of backtracking on BC reservations despite voting in favour of the BC Bill in the Telangana Assembly. "Leaders from all communities in Telangana are united in support of BCs, but BJP is obstructing this cause for political gain," Goud said. Highlighting the Congress government's commitment, he said CM Revanth Reddy took a bold political decision by implementing the Kamareddy Declaration and initiating the caste census, which scientifically documented that BCs constitute 57% of Telangana's population. "This has made Telangana a role model for the nation," he added.

KITS Warangal Holds "Student Orientation Program-2025" for Incoming B.Tech. First-Year Students

Warangal, August 6, 2025 — Kakatiya Institute of Technology & Science, Warangal (KITSW) conducted its annual Student Orientation Program (SOP) for the newly admitted B.Tech. first-year students for the academic year 2025-26. The event was held across five venues within the campus, including the Auditorium and various seminar halls, welcoming over 1,000 students along with their parents. Principal Prof. K. Ashoka Reddy addressed the students, emphasizing the importance of competencies and skills in 21st-century education, highlighting the institute's competence-focused curriculum under the 2024 regulations (URR24). The program aims to impart engineering knowledge, skills, values, and attitudes, fostering a culture of innovation, research, incubation, and entrepreneurship (i2RE). Prof. Reddy encouraged students to be curious and proactive while leveraging the autonomy of the institute to engage in industry-relevant programs designed to develop problem-solving abilities and effective communication skills.



Urban Bank Chairman Gaddam Vilas Reddy Alleges Manipulations by Previous Leadership in Cooperative Society Meeting

Karimnagar, August 5 — Urban Bank Chairman Gaddam Vilas Reddy addressed concerns regarding the recent Sarvasabhaya (General) Meeting held in accordance with the 1964 Cooperative Act. He clarified that if the Mahasabha was postponed earlier, it must be conducted on the same day as rescheduled. Vilas Reddy accused the previous ruling class, particularly between 2007 and 2017, of manipulation and irregularities. He referred to statements by former chairman Karu Rajasekhar, who allegedly cheated the bank and provided false addresses, while important notices remained unserved. The chairman highlighted issues related to gold recovery, noting that although a CEO was suspended, no substantive action had been taken against other involved parties. He questioned why suspension was not applied consistently, mentioning a pending payment of 32 lakhs connected with the matter. Further, Vilas Reddy raised concerns about membership irregularities during the last administration, stating that around 15,000 members were added without active accounts. He also disclosed that 9,000 votes were removed following a home survey that cost 5 lakh, suggesting efforts to cleanse the voter list.

Srinidhi Neocity Venture in Sadashivpet Faces Allegations of Illegal Encroachments and Permit Violations

Sangareddy, August 5 — The Srinidhi Neocity real estate project in Sadashivpet Mandal has come under serious scrutiny amid allegations of illegally encroaching on natural water streams and government land. Locals claim the 99-acre development, promoted as a DTCP-approved layout, has filled and buried four natural streams (vaagus) without proper authorization. Despite clear evidence, irrigation and revenue department officials reportedly deny knowledge of these violations, raising suspicions of willful negligence or complicity. Further accusations include



selling plots across multiple survey numbers without necessary land conversion certificates, Letters of Consent (L.O.C.), or RERA approvals. Buyers allege that the venture falsely claims to have DTCP approval while no such permissions are recorded with the municipality. There are also charges that local elected representatives and officials have enabled these

violations, allegedly influenced by vested interests and bribes. Customers express concern about being misled with false promises and illegal registrations, while municipal officials reportedly misuse the name of the Hyderabad Metropolitan Development Authority (HMDA) to deflect accountability. Public demand is now growing for a thorough investigation by district authorities and strict action against those responsible, along with calls for transparency and justice to protect plot buyers and safeguard the environment.
